**2023-2024 Children's Center Fees and Requirements Preschool Classes/Summer Camp
All Registration Fees are NON-Refundable and due at time of registration.**

Children entering a 3 year old class Must Be Potty Trained.

A \$100.00 Registration Fee/Supply Fee is required for these classes. (\$85.00 if you register before April 1, 2023)

*An \$80.00 activity fee is required at time of registration.

4-Year-Old Classes: Monday through Fridays, 8:30 - 12:00 p.m. Must be 4 by September 1, 2023. Monthly fee is \$325.00 (\$300.00 church members, board Members)

3-Year-Old Classes: Monday through Friday 8:30 a.m. - 12:00 p.m. Must be 3 by September 1, 2023. Monthly fee is \$325.00 (\$300.00 church members, board members)

Early 3's Class: Monday through Friday 8:30 a.m.-12:00 p.m. Must be 3 by March 1, 2024. Monthly fee is \$325.00 (\$300.00 church members, board members)

Early 3's Class Tuesday, Wednesday, Thursday 8:30 a.m. -12:00 p.m. Must be 3 by March 1, 2024. Monthly fee is \$300.00 (\$275.00 church members, board members)

Lil Tots: Tuesday, Wednesday, Thursday 8:30 a.m. – 12:00 p.m. Children ages 1-2. Monthly fee is \$250.00 (\$225.00 church members, board members)

Munch Bunch: Tuesday, Wednesday, Thursday 12:00 p.m.-3:00 p.m. (available for all classes except Lil Tots) NO EXTRA CHARGE

Summer Camp:

Registration fee \$50 for Children's Center families; \$75 for Non-Children's Center families

Lil Tots: Tuesday, Wednesday, Thursday 8:30 a.m.-12:00 p.m. Children ages 1-2. Monthly fee \$250.00

Early 3's: Tuesday, Wednesday, Thursday 8:30 a.m.-12:00 p.m. (extended day until 4:00 p.m.) Monthly fee \$300.00
Monday through Friday Monthly fee \$325.00

Ages 3 (potty trained)-Kindergarten: Available Monday through Friday 8:30 a.m.-3:00 p.m.
3 three week sessions each \$375.00

****PRESCHOOL TUITION IS DIVIDED INTO 9 MONTHLY PAYMENTS DUE THE 1st OF EACH MONTH, SEPTEMBER through MAY and does not change regardless of the number of school days in each month. (A late fee of \$5.00 will be accessed if not paid by the 5th.) Please refer to the handbook for further explanation.**

This card **must** have at least three different emergency numbers; i.e. the Mother, the Father, and one other name and number. Parents are responsible to notify the school in writing of any changes during the year.

In the event of a non-serious injury, the SMCC personnel will administer first-aid as per American Red Cross/Heart Assoc. training procedures and contact the parents if any further treatment is necessary. If no contacts are reached in a reasonable amount of time, EMS will be called if deemed necessary.

In the event of a serious injury, the SMCC will immediately contact EMS and a name from the “Emergency Contact Card” and follow the American First-Aid procedures until EMS arrives.

I give permission for my child (or legal ward) _____ to be treated or attended to by authorized medical personnel in the event of an emergency. I, therefore, hold free from liability Surfside Methodist Children’s Center, staff and all attending medical personnel acting according to the accustomed procedure and rendering general and special medical related treatment on the behalf of and for the goodwill of my child (or legal ward).
